"Rock the Foundation" Returns to House of Blues on March 19 Amidst March Madness, Fundraiser Aims for Record Year

CLEVELAND – Feb. 28, 2011 – The Cleveland Metropolitan Bar Foundation (CMBF) will host its sixth annual Rock the Foundation fundraiser at the House of Blues Cleveland on March 19 from 7 p.m. to 11 p.m.

Open to the public, Rock the Foundation is the ultimate, casual rock-n-roll party, complete with live entertainment from the No Name Band, silent auction, fantastic food, and dancing. General admission tickets are \$111. Tickets for VIP entry are \$250 and include special 6 p.m. access for a pre-event reception with wine tasting, hors d'oeuvres and entertainment by Transportation Boulevard.

Ticket sales, sponsorships and auctions have helped Rock the Foundation generate more than \$480,000 in its first five years for its many innovative and wide-ranging pro bono and community service programs, including The 3Rs (teaching and counseling more than 4,000 students in Cleveland and East Cleveland schools), the homeless legal assistance program (counseling more than 600 people every year), and high school mock trial competitions (bringing the law home to more than 900 students each year).
